

ABSTRACT SUBMISSION GUIDELINES CONFERENCE & CASE PRESENTATION

- Abstract summary and introduction should not exceed 1500 characters. The abstract must be in English, font size 12 in Times New Roman fonts and with single-line spacing.
- Abstracts should be submitted through the online submission portal at www.dubaiderma.com.
- Abstracts that are handwritten, or sent by fax will not be accepted.
- Abstract content must meet the standard of an academic / scientific presentation. In cases of research or clinical study, the abstract must be based on the original research or original clinical case studies, or their modifications.
- Dubai Derma Scientific Organizing Committee will evaluate the content of each abstract and make the final selection of the abstracts for presentation.
- The presentation must cover the same material as the abstract.
- If the abstract has been selected for presentation the speaker automatically gives permission for the abstract published in the conference program or to any postconference announcement.
- No abstracts will be considered after the 30th of November 2024.
- For any withdrawals, the speaker should notify the *organizer in writing as soon as possible or minimum of 2 months prior to the event.
- Any particular equipment and materials which is necessarily to conduct the session is be declared to organizer and approved to be obtained latest by the submission of the presentation.

CLINICAL CASE PRESENTATION ABSTRACT SUBMISSION GUIDELINES

Clinical Case Presentations divided into 3 categories:

Category 1: Resident Dermatologists Competition

Category 2: Junior Dermatologists Competition

Category 3: Open Category

The abstract submissions for Category 1 and 2 need to be accompanied by a proof of status Letter which can be downloaded on the Abstract Submission page on www.dubaiderma.com





Category 1: Resident Dermatologists Competition

To be eligible to join the Resident's Dermatologist Competition, primary author must upload a **proof of status** confirming the position "**Resident Dermatologist**" and must be signed and stamped by the Residency Program Director.

Maximum number of Abstracts which can be submitted under this category is 2.

Category 2: Junior Dermatologists Competition

To be eligible to join the Junior Dermatologists Competition, primary author must upload a **proof of status** confirming the position **Junior Dermatologist** (graduated in the last 3 years) and must be signed and stamped by the Head of the Department.

 The primary author can submit 3 different cases and 1 case should be submitted in one category only: Category 1, Category 2, Category 3, or posters. Duplications of submission will not be possible.

Category 3: Open Category

This category is open for all and the abstracts receive in this category **will not be considered for the**Case presentation competition

- Category 1 and 2 are reserved for clinical case presentations with an eventual short literature review only.
- Please note that the clinical studies should not be submitted in both categories but redirected to Category 3 or posters.
